#### Measurable Goal

**Goal:** By Spring of Year 2, implement EC PBIS with fidelity as measured by:

- All critical elements on the Early Childhood Benchmarks of Quality (BOQ) partially or fully in place, with 80% fully in place
- An overall score of 80% or higher and no red flags on the Teaching Pyramid Observation Tool (TPOT) in each classroom
- Resulting in a decrease in behavior incident reports (BIR).
