





2.0 Process to Address Implementation Challenges



Activity 2.1

- Challenges are inevitable when districts install and implement new practices or refine existing practices!
 - As a group, discuss the following:
 - What are some implementation challenges that school staff may face?
 - How does your district currently learn about and address implementation challenges?



Process to Address Implementation Challenges

Outlines a series of steps taken from the point that the District Implementation Team is made aware of an implementation challenge until the challenge is resolved



Benefits

- Facilitates the use of a program or practice
- Makes the work of staff easier and less burdensome
- Secures the resources necessary to support and sustain a program or practice

(National Implementation Research Network, n.d.)



Impact on Student Outcomes

- A Process to Address Implementation Challenges ensures that mechanisms are in place for districts to:
 - Identify implementation challenges
 - Problem solve and adjust implementation supports to schools
- When implementation improves, so do student outcomes



Components of the Process

- Written process consistently used to remove internal and external challenges and includes:
 - Identification of the types of challenges the process is intended to address
 - List of individuals or teaming structures that will use the process to remove challenges
 - Venues that challenges will be discussed
 - Process for assigning challenges to individuals with authority to remove challenges



Components of Process (continued)

- Measures to ensure individuals with decision making authority understand the scope of the challenge and potential options to address the challenge
- Process for documentation of details including the identified challenge, anticipated steps (and timelines) for removal, individuals assigned to remove, progress on removal
- Process for follow-up with those who identified the challenge to determine if the challenge was addressed sufficiently

- Your Implementation Specialist will facilitate a discussion to support the development of your district's Process to Address Implementation Challenges
 - Develop a draft Process to Address Implementation Challenges for your district
 - Practice using the process to shape and refine it
 - Consider what information you will share with DIT members around the Process to Address Implementation Challenges (e.g., definition, purpose, template, how to use, next steps) and how that information will be shared.
- Once the process has been finalized, it will need to be reviewed and approved by executive leadership



Using the Process

- As school staff work to install and implement MTSS, the DIT supports the use of a process to address the challenges schools are unable to remove on their own
- Examples of consistent use include:
 - Standing agenda item on identified team meeting agendas under the topic of "Implementation Challenges"
 - DIT reviews and updates Implementation Challenge Log monthly
 - Follow-up conversations are documented and used to determine if challenges are effectively addressed and removed

Big Ideas and Next Steps

Big Ideas

- Challenges are inevitable when districts install or refine initiatives
- It's critical that districts have a process in place to identify and resolve challenges that impede implementation of initiatives
- Development and use of a process that outlines the steps to be taken to address challenges makes it more likely that school and district-level implementation can move forward as desired
