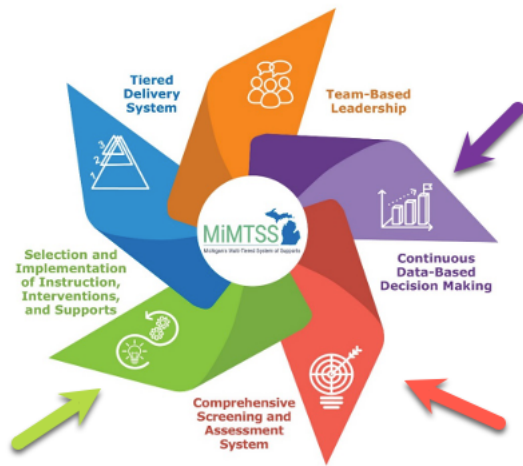
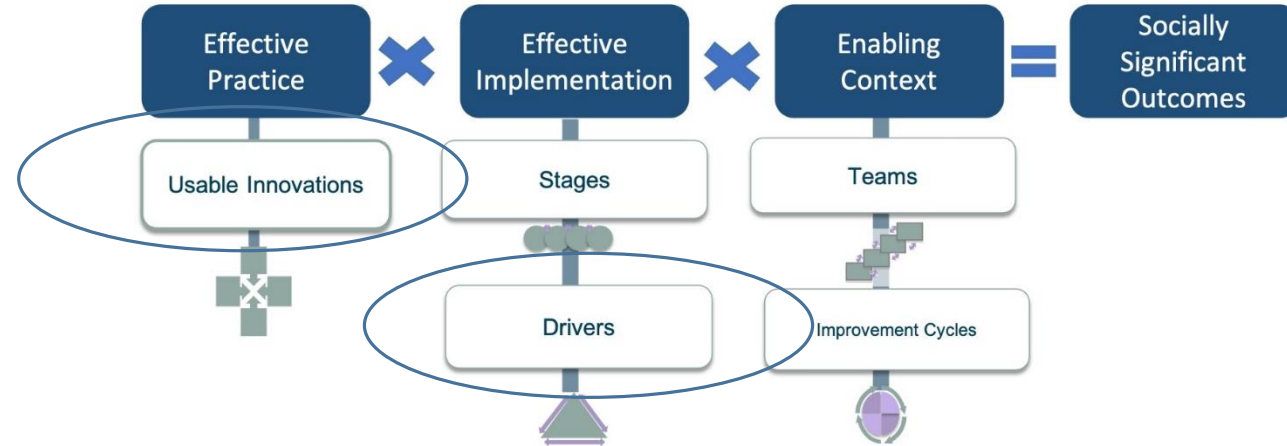
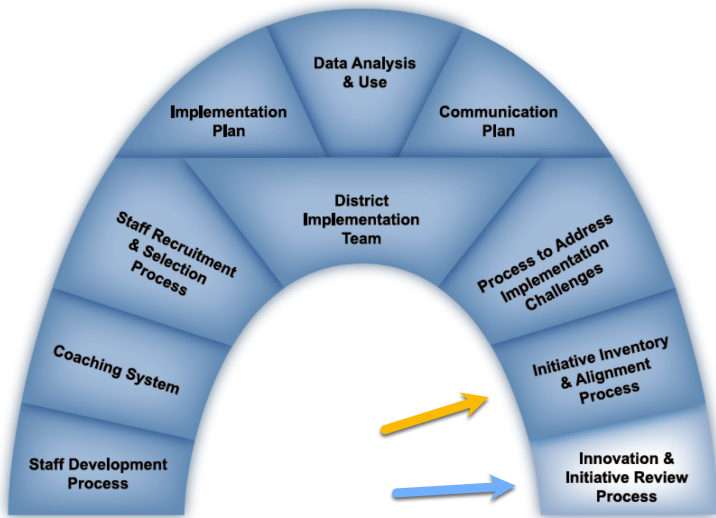


Figure 1. MDE's five essential components of a Multi-Tiered System of Supports (MTSS) framework

2.0 Initiative and Innovation Review Process

Initiative and Innovation Review and Selection Process

A process that leads to careful analysis of a proposed initiative or innovation (e.g., evidence-based programs, practices, assessments) to inform a selection or de-selection decision.



Activity 2.1

- As a team, discuss the following questions:
 - How are decisions about selection and deselection of initiatives currently made in your district?
 - What benefits, if any, do you think a district initiative and innovation review process brings to a district?
 - What concerns or potential issues might you anticipate around the use of a district initiative and innovation review process?

Benefits

- Increased confidence in the following:
 - Initiatives, programs, practices, and assessments are the best available
 - District has a full understanding of the resources needed to successfully use the selected initiatives and innovations
 - District has the capacity to support and sustain use of innovations as intended (e.g., training, coaching)
 - Decisions that resulted in not selecting an innovation or de-selecting the use of an existing innovation were the result of a thorough analysis of critical factors

Impact on Student Outcomes

- Taking the time to conduct a thorough review of initiative and innovations will result in the selection of programs, practices, and assessments that are
 - Supported by the district
 - Used as intended
 - Scaled-up
 - Sustained over time
- When effective practices are selected, supported and implemented well, the result is successful outcomes for students

Initiative and Innovation Review and Selection Process Components

- Written process
- Conditions that warrant use of the process
- Analysis of program indicators:
 - Evidence to demonstrate effectiveness
 - Readiness for usability
 - Supports available
- Analysis of implementation site indicators:
 - Need for the initiative
 - Fit and alignment with other initiatives
 - Resources/capacity needed to fully implement

Activity 2.2

 - Are there other ideas for how to develop a district Initiative and Innovation Review and Selection Process?



Activity 2.3

- Your Implementation Specialist will facilitate a discussion to support the development of the district's Initiative and Innovation Review and Selection Process.
 - Develop a draft process for your district
 - Consider what information you will share with DIT members around the process (e.g., definition, purpose, template, how to use, next steps) and how that information will be shared.
 - Develop action items to get feedback on the process and input from critical groups and teams on the contents of the process.
- Once the process has been finalized it will need to be approved by executive leadership and shared with critical groups and teams.

Considerations for Use

- Adequate preparation, additional learning, or additional support may be needed to ensure questions are answered accurately
- Prior to completing the process, documents and information may need to be gathered to support completion of the tool
- It may take multiple sessions to complete the process
- Pre-correct that the goal is to objectively complete the review process and summarize the results for decision makers

Using the Process

- When school and district leaders are approached with opportunities to select or deselect initiatives, the district Initiative and Innovation Review and Selection Process will be used to carefully analyze those initiatives.
- Examples of consistent use include:
 - Annual reminders to staff to use the process
 - The need to discuss Initiative and Innovation Review and Selection is considered as meeting agendas are developed
 - Process is completed in its entirety when initiatives are considered

3.0 Big Ideas and Next Steps

Big Ideas and Next Steps

- Big Ideas
 - Districts regularly receive requests to adopt (and/or discontinue) initiatives
 - It's critical that districts have a process in place to engage in careful analysis of initiatives to ensure they are the best available
 - Development and use of a process to review and select initiatives increase the likelihood that effective practices are selected, supported, and implemented well
- Next Steps
 - Update DIT Installation Checklists until they are 100% complete
