

Example DCA Data Sources

This document provides DCA administrators with an example of how DCA data sources could be organized to support the District Implementation Team in accurately self-assessing their district implementation infrastructure.

In the table below, components and concepts related to the installation and use of the district implementation infrastructure are aligned to corresponding DCA items and example district data sources. Example data sources were provided by an intensive TA district and contextualize to reflect the processes developed specific to their district.
